INSTRUCTIONS TO THE APPLICANTS

1. The candidate seeking admission to four year B.Tech. Course should submit the application with this institute in the prescribed form.
2. The candidate should personally write Application Form in English.
3. Application should provide all the details along with the relevant certificates and testimonials. Incomplete applications will not be considered.
4. Applications received after the due date will be rejected irrespective of the postal delays or any other reason.
5. The lists of students provisionally admitted will be displayed on the Notice Board.
6. The admission will be provisional and shall be cancelled at any stage and no refund of the fee is made if the information furnished by the candidate is found to be false or misleading.
7. Ragging is prohibited. Any student if found involved in ragging will be expelled from the institution. The first year students are advised to report in confidence to the Director / Principal, HOD or Member of the Anti-Ragging committee if they are subjected to ragging by any student. This will help us in tackling the menace which is a cognizable offence as per the Presidential Order and State Government Anti Ragging Act.
8. The student should inform any change in the address of their parent / guardian to the office of the institute immediately.
9. Students of Nizam Group of Institutions are not permitted to resort to strikes, demonstrations in and around the institute. Any problem they face, can be represented to the concerned Heads of the Departments and the Principal / Director through their class representatives.
